Reservation is as per Rly Bd's L.No.- E(MPP)2002/6/10 Dtd- 17.06.11, the reserved places are - SC 15%, ST 7.5% and OBC 27%. If the prescribed number of person belonging either to Scheduled Castes or Scheduled Tribes are not available, then the seats so reserved for them may be filled by persons exchanging the posts between reserved for Scheduled Tribes and Scheduled Castes. If the prescribed seats can not be filled even in the above given manner then the seats so lying unfilled may be filled by persons belonging to unreserved category. Similarly the seats remaining unfilled by OBC candidates will be filled up by unreserved category.

** 03% of total seats are reserved for Ex.-Service Men, their children and children of Armed Force Personnel, as per details mentioned below-

- (a) Children of deceased/disabled Ex-serviceman including those killed/disabled during peace time.
- (b) Children of ex-serviceman.
- (c) Children of serving jawans.
- (d) Children of serving officers.
- (e) Ex-serviceman.

*** 03% of total seats will be reserved for physically handicapped candidates. only loco motor or Cerebral palsy (OH) who suffers from not less than 40% of relevant disability and Hearing handicapped having 60 decibels or more in the better ear in the conversational range of frequency are eligible to apply. A physical handicapped person who wants to avail the benefit of reservation would have to submit a disability certificate issued by a competent authority i.e. Medical Board constituted by the Central or State Government.

2. <u>Training period and Training Place</u>- Training period will be as per Railway Board's letter dated- 22.07.02 (RBE No.- 119/2002). Training place will be **Mech. (C&W) Depot , Electric Loco Shed and T.M.S. Kanpur.**

ELIGIBILITY-

3. <u>Age limit</u>-

(a) Candidate must have completed 15 years and should not have completed 24 years of age as on 30.11.2018

(b) The upper age limit may be relaxed by five years in case of SC/ST candidates and three years in case of OBC candidates.

(c) For physically handicapped persons, upper age limit is relaxed by 10 years.

4. <u>Educational qualification</u>- The candidate must have passed 10th class examination or its equivalent (under 10+2 system) with **50% marks** and **ITI pass** certificate in related trade from a recognized Industrial Training Institute affiliated to NCVT.

5. <u>Stipend</u>- Stipend will be paid as per instructions issued by Railway Board from time to time.

6. form line NCR Applicants will fill their on on the website www.ncr.indianrailways.gov.in . The applicants will login on NCR website www.ncr.indianrailways.gov.in ---News and Recruitment → Act Apprentice Notification ALD Division and click. On the ensuing window the candidate will click Act Apprentice Notification 2018-19 ALD Division and fill the online form. After filling up the form the candidate will also take a print out of the form and submit the same alongwith attested Photostat copy of High School or its equivalent (under 10+2 system) Marksheet, Certificate, ITI marksheet (all semesters) and ITI certificate issued by NCVT in an envelope and sent to Office of the Sr. Divisional Personnel Officer, Personnel Branch/Recruitment Section, Room No. 112, Allahabad Division North Central Railway, Allahabad (Uttar Pradesh), Pin Code- 211001. The following must be annexed with online printout application in the envelope :-

6.1 A postal order / Demand Draft of Rs. 100/- addressed to Sr. DFM / NCR / ALD as processing fee which is not refundable is to be enclosed with the application form. No fee is required to be paid by SC / ST / PH / women candidates.

6.2 The candidate has to paste one passport size recent photograph on the online printout application form on the appropriate place. Photograph must be attested by a Gazetted Officer.

6.3 Candidate must ensure before submission of online application that he/she is fulfilling qualifications and other standards prescribed. If any candidate does not fulfill the prescribed qualification and other eligibility criteria, the administration has the right to cancel / reject such application at any stage of selection process and if the candidate has been engaged for training, his/her candidature will be cancelled without prior intimation.

7. <u>Last date</u>- The last date of receiving of the complete online printout application form in all respects in the office is **31.12-2018 at 17:45 PM** by ordinary post only. The candidates may also drop his/her application in the box on any working day between 10.00 AM to 17:45 PM up to 31-12-2018 in the Office of Sr. Divisional Personnel Officer, Allahabad (Personnel Branch/Recruitment Section - Room No. 112).

8. <u>Precautions for submission of application</u>- The applicant's name, father and mother's name should be clearly mentioned on the online application form(abbreviations should be strictly avoided). Application without attested copies of SC / ST / OBC / Handicapped Certificate / Educational / Technical qualification certificate will not be accepted. The candidates who have passed I.T.I. from S.C.V.T. are not eligible to apply and no correspondence will be entertained from any person or organization in such applications and no reply will be given. No application will be accepted after last date. **Office of the Sr. Divisional Personnel Officer, Personnel Branch/Recruitment Section** will not be responsible for late or wrong delivery of postal department at any stage of engagement process.

<u>"Application under Apprentice Act, 1961 for the year 2018-19 in Mech (</u> <u>C&W</u>) depot, Electric Loco Shed and T.M.S. / Kanpur, North Central Railway" must be clearly mentioned on the envelope.

9. Selection Process-

(i) The selection of Act Apprentice for training will be done on the basis of merit list of the candidates who have applied and are eligible in reference to the notification. There will be no written exam or interview/oral exam in this selection.

(ii) Merit list will be prepared on the basis of percentage of total marks obtained in 10th or its equivalent Exam by a candidate from recognized educational Board / Institute plus ITI examination marks.

(iii) The calculation of percentage of marks will be based on the total marks obtained in 10th or its equivalent Exam plus ITI examination marks and not on the basis of marks of any subject or a group of subjects.

(iv) If more than one candidate gets equal marks/percentage in 10th Exam plus ITI marks then the older candidate whose date of birth is earlier will be higher in rank than the other whose date of birth is later.

(v) Trade/Community/Category wise Select List will be prepared on the basis of merit.

(vi) The candidates placed in the select list will be called for verification of documents in due time.

(vii) The candidate will be declared fit for training after being given the medical fitness certificate on successful medical examination by Authorized Railway Medical Officer. If the candidate fails in medical examination, his/her candidature will be cancelled and he/she will have no right for training.

(viii) No Daily allowance or Travelling allowance will be admissible.

(ix) Hostel/Residential facility will not be provided to selected candidates and as per Apprentice Act, 1961 the selected candidates have to arrange accommodation for themselves.

9.1 There is no guarantee of employment in railway on completion of their training under Apprentice Act, 1961.

9.2 <u>The candidates who have already completed their training under Apprentice</u> <u>Act, 1961 from any institute/establishment are not eligible to apply under this</u> <u>notification.</u>

10. <u>Agreement of Training</u>- The selected candidate or his/her guardian (in case of minor) has to execute an apprenticeship contract or agreement with employer before apprenticeship training as prescribed under the Apprentice Act, 1961.

11. After completion of training every apprentice has to undergo to Trade Test conducted by Director General, Employment &Training, Ministry of Labour & Employment, New Delhi. Passed candidate will get National Trade Certificate but there is **no guarantee of employment**.

12. The decision of administration regarding selection of candidates and their training will be final. If at a later stage it is found that the selected candidate has given wrong / false information, then the candidate will be dismissed without giving any notice.
