

Note- There will be 3% reservation to Divyang (PwD) & 3% reservation to the Ex-Servicemen & Wards of Ex-Servicemen & Armed Forces Personnel from their community (UR/SC/ST/OBC) in terms of Railway Board Letter No.E(MPP)2003/6/14 dated 09.12.2003 (RBE-213/2003) and E(NG)II/2009/RR-1/10 dated 23.07.2015 (RBE-83/2015).

- 3. Age Limits:- The candidates must not be less than 15 years of age and not more than 24 years of age as on 29.12.2018. In the case of SC/ST candidate's upper age limit is relaxed by 5 years and in the case of OBC candidates, the upper age limit is relaxed by 3 years. For Divyang(PwD) candidates maximum 10 years age relaxation is permitted.
- 4. Essential Qualification-The candidate should have already passed the prescribed qualification of High School/10<sup>th</sup> with minimum 50% marks & ITI in notified trade on the date of issue of notification from recognised Board.



- 5. <u>Physical Standard-</u> Selected candidates will be required to pass the prescribed medical examination as per rules in force before induction into the training course. Eligibility of Divyang for particular trade shall be governed by Railway Boards guidelines.
- **6.** <u>Processing Fee-</u>The candidates will have to pay Rs.100/- as processing fee. SC/ST/ Divyang(PwD)/ Women candidates are exempted from payment of processing fee.
- 7. <u>Mode of Application-</u> Candidates are required to submit their applications & processing fee (Rs.100/-) online. Before submitting online application, the candidate should ensure himself that they are eligible under this notification. Server will be opened at 10.00 hrs on 30.11.2018 for online application and will be closed at 17.00 hrs on 29.12.2018.
- 8. Mode of Selection:- Selection of the eligible candidates for imparting training under the Apprentice Act, 196l will be based on the percentage of marks obtained in High School/10<sup>th</sup> examination. Candidates may opt for more than one unit/place. In case, his merit position does not permit to allot first choice, he will be allotted subsequent choice. Selected candidates will be called for document verification at Gorakhpur and they will have to bring a copy of online application, one passport size photograph, all their original certificates & testimonials for verification purpose. After document verification, the eligible candidates will be subjected to medical examination by Railway certified Railway Doctor at allotted Division/Unit.
- 9. <u>Training & stipend:-</u>Training will be arranged in accordance with the standards and syllabus prescribed by the Central Apprenticeship Council. The selected candidates will be paid stipend during Apprenticeship at the prescribed rates as per extant instructions.
- 10. <u>Disclaimer-Act</u> apprentices imparted training in Railway establishments will have no claim to seek employment on Railways on the basis of such training.
- 11. <u>Cancellation of earlier notifications-</u>Any notifications for apprentice training in above units for year 2018-19 stands cancelled and all such candidates are required to fill online application for this purpose.

## 12. Other Conditions-

- a. Canvassing in any form would be a disqualification.
- **b.** The candidates who are called for verification of certificates are not eligible for any Travelling/Dearness Allowances.
- c. Engineering Graduates and Diploma holders are not eligible to apply for apprenticeship in response to this notification as they are governed by separate scheme of apprenticeship.

- d. The selected candidates shall execute a contract of Apprenticeship under the Apprentices Act, 1961 and if such a candidate is a minor, his parent/Guardian shall execute the prescribed contract. The Apprentices shall be governed by the provisions of Apprentices Apprenticeship Rules, 1962 as amended from time to time and such Rules and Regulations applicable to them.
- e. In case an Apprentice discontinues the apprenticeship training and fails to fulfil the obligations as per his contract without valid reasons, he shall have to refund the stipend paid to him, the cost of training and such other costs that may be determined under the Rules by the Railway Administration.
- f. The candidature for training is liable to be cancelled at any time if false declaration discovered and candidates are not adhering Rules & Regulations of Railways. The decision of the Railway Administration in this regard will be final and binding. No further correspondence in this regard would be entertained.
